

Tiered Bonus Program

Participating Contractors in good standing can receive a tiered bonus on electric base rebates. Bonuses decrease over time and funds are limited so get your application in early. Project must be complete with a complete final application submitted by the dates below.



- · Applicant must be a Participating Contractor to qualify.
- Offer available on new final applications submitted from January 18, 2024 through October 31, 2024. Available on electric base rebates only.
- Bonus rebates paid directly to Participating Contractor with no cap.
- Bonus will be paid on a first come, first served basis and is subject to end early based on available funds.
- · May apply for bonus on multiple projects.
- Bonus will automatically be applied to application at the time of review.
- Participating Contractor must be in good standing at time of final application submittal. 2023 Participating Contractors must attend training and submit form by March 31, 2024 to maintain 2024 Participating Contractor status.

Performance Bonus Program

To show our gratitude to our Participating Contractors, this program year we're offering a performance-based bonus. Participating Contractors who increase their production year- over-year by at least 10% or more earns a 10% bonus and beyond - all the way to 30%! Check out the examples below for details on how to earn your performance bonus.

Example 1:

Participating Contractor produced \$100,000 in electric base rebates in 2023

2024 Production	% Change	Bonus Amount
\$105,000	+5%	Doesn't qualify (<10%)
\$115,000	+15%	\$17,250
\$140,000	+40%	\$42,000 (max 30%)

Example 2:

Participating Contractor produced \$2,000 in electric base rebates in 2023

2024 Production	% Change	Bonus Amount
\$10,000	-50%	Doesn't qualify (<\$20k)
\$22,000	+10%	\$2,200
\$105,000	+525%	\$31,500 (max 30%)

- Applicant must be a Participating Contractor to qualify.
- Only paid base electric rebates on final applications submitted during the 2024 program year are eligible.
- Participating Contractor must submit a minimum of \$20,000 or 10% above 2023 production, whichever is higher, to be eligible. If 2023 production was lower than \$20k, adopt a \$20,000 baseline for 2023 paid base electric rebates.
- Bonus rebate paid in 1% increments directly to Participating Contractor with no cap.
- Can be combined with all other bonus offers.
- Bonus will be calculated for new application electric base rebates only and will be paid upon the close of the 2024 program year.
- Participating Contractor must be in good standing at the end of the 2024 program year on November 30, 2024 to qualify.
